Representative Alice Peisch attended our coffee hour on Saturday, January 29 to discuss her priorities for this legislative session. She was very pleased to have been recently named Chair of the Education Committee, which she indicated had been her goal throughout her years in the Legislature. She said that most of the legislation she files is the result of requests from her constituents. Among her priorities this session is a bill that removes from police logs in local papers the address as well as the name of a victim of domestic violence. She believes some abuse victims fail to report their abuse for fear that their friends and neighbors will find out about their plight.

She also will support the "Good Samaritan Bill" requested by a constituent, which would keep reporters of drug overdoses (as well as the individual overdosing) from prosecution. This can be especially worrisome for teens and other young people, who might not report in time to save the victim. In addition, she will support recent recommendations to reform alimony laws (Alimony Reform Act of 2011) by making them more fair to all participants, by allowing courts more flexibility and more discretion to fit each case, taking into account factors like length of the marriage and age of the parties.

She also supports more flexibility in lead paint removal laws, citing the well-publicized case of a Wellesley family which was forced to pay exorbitant costs to de-lead their new house, even though they had just moved in, and their young child's extremely high blood lead levels would have had to come from their previous house or, as the pediatrician believed, from the toy necklace imported from China which she sucked habitually.

Town Caucus is coming up on Monday, March 7 at 7:30 in the auditorium at Town Hall. Each town board has one or two seats for which the current occupant's term as expired. Many of these incumbents will, of course, be running for another term,

but this is the time for newcomers to get involved by throwing a hat in the ring. Town elections will take place on Saturday, May 7, with Town following two nights later.

A small but intrepid group met last week to discuss Michael Specter's *Denialism: How Irrational Thinking Hinders Scientific Progress, Harms Our Planet, and Threatens Our Lives*. The author posits that Americans mistrust science more today than ever before, giving examples such as some parents' belief that childhood vaccines can cause autism, and the money spent on organic foods, vitamins and "natural" cures. He also wrote at length about the rejection by some European and African governments of genetically modified grains, even as

their people are starving. It was an interesting juxtaposition with a previous League Book Club selection, Michael Pollen's *The Omnivore's Dilemma*.

I would like to draw your attention to the upcoming conference on *Women's Health in the 21st Century: What We Need to Know*, on Saturday morning, March 5 in Framingham. Details can be found elsewhere in this Bulletin. If you'd like to carpool, email me at tackc@aol.com.

COMMUNITY PRESERVATION COMMITTEE

The Community Preservation Committee continues to work with the Housing Partnership to help identify values and parameters under which the CPC would support a Housing Trust. The Housing Partnership continues to have the goal of seeking approval to create the Housing Trust at May Town Meeting. The Housing Partnership has been working long and hard to find the right balance of flexibility and accountability necessary to make this type of structure work for Weston. There seems to be a growing understanding that the Housing Trust will have to start with some small projects in order to build credibility and understanding before seeking and tackling larger projects.

The Community Preservation Committee continues to evaluate proposals for funds which, if recommended by the Committee, will be brought to May Town Meeting for approval there. Some possible projects include renovations (roof and windows) to the older Brook School

Apartment buildings, a possible affordable-housing renovation of buildings that the Town owns on Warren Avenue, some additional Case Estates preservation efforts (when that purchase closes), additional field work, funding for our share of a regional community housing expert, and others. The Committee will continue to review these proposals, and there will be a public hearing on March 14, after which the Community Preservation Committee will vote on whether to recommend each of the projects.

The Cecil Group's next meeting on finding a consensus for re-uses of the Old Library and the Josiah Smith Tavern will take place Wednesday evening, February 16, in the upstairs at Town Hall.

I encourage each of you to participate in the discussion about the re-use of these buildings, and to attend the CPC Public Hearing in March.

Weston Ambulance Ranked #1 Nationally in Service for 4th Quarter 2010

The Weston Fire Department ambulance service was ranked #1 in quality of service for the 4th quarter 2010 among 49 departments nationally, including 9 from Massachusetts, that participate in the survey process.

Go about 1.88 miles and turn left onto Lincoln Street. Turn left into a parking lot in front of Framingham Union Hospital or across the street from it. McPherson Hall is in the Medical Arts Bldg. at 85 Lincoln St. **From the east:** Take Route 9. Turn right onto Main St. and follow above directions. **By train:** Take train to Framingham. Walk 2 blocks east to Union Street; turn left onto Union Street; walk 3 blocks (on the right). Turn right onto Henry St., walk one block. The Medical Arts Bldg at 85 Lincoln St. will be across the street.

Directions to Hadley church: Take Route 9 to Hadley. At the intersection with N. Maple St. (Taco Bell, Home Depot), turn at the lights toward Home Depot. NEW TWO-FAMILY AFFORDABLE HOUSING IN TOWN

On a sunny and cold Sunday afternoon at the end of January, the Weston Affordable Housing Foundation held an open house at the newly constructed two-family house at 23 and 25 Pine Street. The large turnout saw the two units, each with 3 bedrooms, 2 ½ baths, kitchen, living room, basement office, and private deck.

The house is exceptionally energy-efficient, featuring dramatic passive solar heating window systems designed and donated by Hunter-Douglas as well as an active solar hot water heating system, heating and cooling systems with a high-efficiency heat exchanger system, high levels of insulation in the ceilings, walls, and basement, and triple-glazed windows.

Weston Affordable Housing Foundation is a nonprofit 501c(3) organization whose mission is to create and support affordable housing options in Weston. It owns several affordable houses which it maintains as rental units. The Pine Street house was made possible through a donation of land from Polly Dickson. The previous house built by WAHFI in 2008 was made possible through the donation of land by Clover Nicholas and Rex DuPont.

WAHFI President Ed Coburn dedicated the two new units -- one to Ed & Polly Dickson, long-time Weston residents and supporters of affordable housing in Weston, and the other to Cam and Eleanor Searle, also long-time residents who were the founding President and Treasurer of the foundation.

The house will now be made available for rent to qualified tenants through a lottery. Information packets and applications are available at the links below, on the town's website (<http://www.weston.org>) and at the Town Hall. Also see the following page for information on lottery deadlines.
