OPENING MESSAGE

Katty Chace

Representative Alice Peisch (and maybe Senator Susan Fargo) will be joining us for a Coffee Hour at the Library community Room on Saturday, January 29 at 11:00 am. The topic will be events on Beacon Hill and Representative Peisch's priorities for the current legislative session. It's a great opportunity to ask questions and get a good conversation going with your representatives. Please take the time to join us.

On Wednesday evening, February 9 at 7:30, we will be holding our annual League Book Club to discuss Denialism by Michael Specter. This intriguing book posits that we have become a society that increasingly questions scientific data and refuses to believe what the facts tell us. There is plenty of grist for good debate. We will be meeting at Barbara Fullerton's at 3 Winter Street.

Barbara Hill, Robin Coutts and I attended a strategic planning session in Natick, organized by the Massachusetts League of women Voters. About 25 members of local Leagues brainstormed, answering questions about which state League activities are the most important to us, and how valuable the services of the state and National Leagues are, and ways in which they could be more helpful to us in the future. All of this information will eventually be collated and made available for better planning in the future (See article on page 10).

On Monday morning I attended the 12th Annual Martin Luther King Day Breakfast at Saint Peter's, sponsored ICARE (Interfaith Citizens Advocating Racial Equality). The speaker was Weston resident Dr. Augustus White, who recently wrote a memoir entitled: "Seeing Patients: Unconscious Bias in Health Care". This book calls for more diversity in the field of medicine and an end to the disparities endured by minorities (including women and the elderly, as well as African-Americans and Hispanics). Dr. White writes that this disparity is "the last frontier of racial prejudice". White grew up in Memphis, TN during the Jim Crow era. The son of a doctor and a teacher, he attended Mount

Herman School in Western Massachusetts, then Brown University. He was the first African-American to graduate from Stanford University Medical School, then the first black to become a resident and surgery professor at Yale. He served in the U.S. Army Medical Corps during the Vietnam War. "I kept a journal and saw a lot of horrible things. Over time that changed me." He left the Army a strong opponent of the war. He is currently a professor of medical education at Harvard Medical School.

Our League Book Club is reading "Denialism" by Michael Specter, and will meet to discuss it on Wednesday, February 9 at 7:30 p.m. at Barbara Fullerton's house (3 Winter Street). Please join us for some thought-provoking discussion.



Directions to Framingham: By car from the west: Take Route. 9. Turn left onto Main St. Continue about .02 of a mile to Union Street (a slight turn right). Go about 1.88 miles and turn left onto Lincoln Street. Turn left into a parking lot in front of Framingham Union Hospital or across the street from it. McPherson Hall is in the Medical Arts Bldg. at 85 Lincoln St. From the east: Take Route 9. Turn right onto Main St. and follow above directions. By train: Take train to Framingham. Walk 2 blocks east to Union Street; turn left onto Union Street; walk 3 blocks (on the right). Turn right onto Henry St., walk one block. The Medical Arts Bldg at 85 Lincoln St. will be across the street.

Directions to Hadley church: Take Route 9 to Hadley. At the intersection with N. Maple St. (Taco Bell, Home Depot), turn at the lights <u>toward</u> Home Depot. Continue straight thru the next lights at the Rocky Hill Rd. intersection. The church will be on your left just a short distance past that intersection.

he Weston Affordable Housing Foundation, Inc. (WAHFI) is preparing to initiate a lottery to select tenants for the two-family house they are completing at 23 Pine Street . In advance of the lottery we are holding an open house so applicants, neighbors, town officials, and other residents of Weston can see this great new addition to Weston's affordable housing stock. The open house will be on Sunday, January 23 from 2-3:00.

There will be a very brief ceremony to formally open the housing and to unveil plaques dedicating each of the two units:

- 25 Pine Street shall henceforth be known as the Fish House, to honor the vision and tireless commitment of Ken Fish who was not only the founding President of WAHFI but also for his instrumental roles in creation of affordable housing at Merriam Village and Dickson Meadows.

Please join us in celebrating the opening of this house which we believe is a credit to this town's commitment to affordable housing and leadership in energy-efficiency.

FOCUS GROUPS

his month the Board of the League of Women Voters of Massachusetts has been holding a series of Focus Groups, Face-to-Face and Online, to help the LWVMA determine how it can best serve its local leagues and members. Katty Chace, Robin Coutts and I (Barbara Hill) attended a Face to Face Focus Group in Natick on January 11. Approximately 8 - 10 MetroWest Leagues were represented in our meeting: Brookline, Needham, Newton, Belmont, Weston, Worcester and more. Most Leagues had several people in attendance. Other Face to Face Focus Group sessions were held in Weymouth, Middleton and Florence. In addition there were a number of opportunities to participate online.

The Focus Group we attended was professionally run, with a very timely leader, a scribe and a specific series of questions. Professional facilitators donated their expertise to gather information designed to determine what members think are the key areas that the LWV MA should work on, should continue doing and should improve. LWV MA President, Zaxaro Bennett, spoke briefly and encouraged honest feedback --- and she got it.

There was a large range of opinions about what the League priorities should be, how important the State League is to the success of the Local Leagues. There was some consensus that the LWV MA should continue Voter Registration and Education, Studies/Re-Studies, Public Forums and Training Workshops. There was scattered support for many of the League's other activities. Almost universally, there was support for a better website presence and support. Universally Local

Leagues are struggling financially.

There was some discussion as well on the issue of membership problems: 30% of League members have belonged for 30 or more years; 43% have belonged for 20 or more years. 73% are over 55 years old, and 47% are over 65 years old. We can all understand intuitively why there is a dearth of young members, but nonetheless we must find ways to encourage people under 50, under 40, and even under 30 to join the League to ensure the continuation of this vital, important organization, particularly in these very trying political times.

True to the League's flyer, we were done in 1 - 1/2 hours, and now we wait for the compilation of the information, as well as a report from the strategic planning committee.

Towards the end of the Focus Group we reviewed the LWV MA Mission Statement, and I offer it for your consideration as well:

"The League of Women Voters of Massachusetts, a nonpartisan political organization, encourages informed and active participation in government, works to increase understanding of major public policy issues, and influences public policy through education and advocacy."

As we go forward in this polarized partisan political climate, I cannot imagine a more important mission. I encourage each of you to continue to participate and to seek ways to make the League's future successful.

Weston Board Of Selectmen Tuesday, Jan. 11, 2011

1. Regional Housing Inter-Municipal Agreement

This will help to form a regional group and includes Weston, Lexington, Bedford, Concord, Lincoln and Sudbury. Weston will contribute \$11,420 for FY 12 which is 13% of the expected work. This group would handle the second lottery for affordable housing. The contractor would do the first.

2. FY12 Proposed Budget and Financing Plan

This proposed budget was presented by Town Manager, Donna VanderClock. It provides the same level of service, however demand has increased in some areas, such as schools.

Revenue is projected to increase by 4.5% and expenses will increase by 4.5% also. Property taxes are estimated to increase by 5.3% and state aid will likely decrease by 15%.

Schools are proposed to increase 2.9% and the unclassified area to increase 8.3% (due to pension obligations)

Budget requests include two more dispatchers for the Fire Department and ten hours more to support the Planning and Land Use areas.

There is no net change in General Fund.

A request to begin the installations for automatic meter reading was not recommended at this time.

Under planning for the unexpected and for financial stability, \$700k would be taken from "free cash" and \$250k from the stabilization fund.

Current "unknowns" are the amount of state aid, the cost of the GIC health insurance plan, any debt exclusion to be voted and new requests approved at town meeting.

3. CPA Requests

Old library – a placeholder of \$800k

Support for the Housing Partnership \$11,420 plus \$4,600

Case Estates – a placeholder. There is \$4.3 million remaining for Parcel 9 and the town has more than \$3 million

Elderly Housing – Brook School \$600k

4. Designate Town Manager to be Voting Delegate for MMA & MIIA Annual Meetings

This was approved.

5. Fee for Replacement Transfer Station Sticker

This is \$15 now and was approved to be lowered to \$5

PUBLIC TRANSPORTATION ADVISORY COMMITTEE VOLUNTEERS NEEDED

The Board of Selectmen would like to hear from Weston residents wishing to serve on the Town's newly created Public Transportation Advisory Committee (PTAC). This Committee is tasked with evaluating current services, identifying opportunities and unmet needs, and providing recommendations to the Board of Selectmen, Weston's MBTA Advisory Board Representative, and Weston's Metro-West Regional Transit Authority Representative.

The PTAC shall consist of at least five Weston residents with an interest in public transportation. The Town's MBTA Advisory Board Representative and MWRTA Board Member shall both serve as ex-officio members of the committee. The committee should report at least twice each year to the Board of Selectmen.
