## OPENING MESSAGE

**P**lease take this opportunity to pay your dues for the year now, while it's on your mind. You can find a membership form in the back of this Bulletin.

I'm pleased that our new State Senator, Mike Barrett of Lexington, will be our guest at a coffee hour on Saturday, February 9 at 11:00 at the library. Mike is looking forward to meeting Weston residents, and hearing about our interests and concerns. I will ask him to tell us about himself, and highlight his legislative priorities for this legislative session. We have also invited State Representative Alice Peisch to attend.

Plans are humming for our 5th Annual Civics Bee on Sunday, March 3 at the Weston Community Center. We are looking for three adult team members to take on teams from Wayland and Sudbury, so please call me with any suggestions of people you think might enjoy participating. Questions this year will again be about the Constitution and the Bill of Rights, but will also focus on the early (Colonial) history of the towns, in honor of Weston's 300th birthday celebration, and Wayland and Sudbury's 375th. Did you know that Wayland and Sudbury were once united as one town?

A Special Town Meeting took place on Monday, November 26. The start of the meeting was delayed for ten minutes until a quorum of 80 was achieved. (Interesting, since the quorum was raised from 40 to 80 at last May's Annual Town Meeting.) The articles passed quickly and without much debate. Article 7, which proposed a change in the zoning by-law pertaining to tear-downs on non-conforming lots, was passed over.

On Saturday, January 12, the celebration of Weston300 will be kicked off with a Winterfest on the Town Green, featuring skating (on the two newly-installed rinks), snowman-building contests, ice sculptures, cocoa and hot cider, and marshmallow roasting. It all sounds like great fun. Let's hope for no January thaw!

## BOARD HIGHLIGHTS

Kathleen Rousseau

The December meeting was held at the home of Kathleen Rousseau. We were pleased to have as our guests two Weston High School students who will be helping us out this year as a part of their political science class.

**Coffee Hour:** February 9 at the Library. We will be having a meeting with Mike Barrett (and perhaps Alice Peisch) to hear about the current issues on Beacon Hill.

**The Civics Bee** will be on March 3 with Professor Richard Alpert as our judge. The focus this year will be on local history as well as the Constitution and Bill of Rights. Weston is celebrating its 300<sup>th</sup> year, and Sudbury and Wayland will be celebrating their 375<sup>th</sup> next year. It will be held at the recreation department great room. We are looking for adults to be members of the team.

**Town Meeting:** The zoning by-law, question 7, was passed over. There was conflict between the zoning board and the planning board on this issue. Pam Fox has now stepped down from the Planning Board. Many on the LWV Board felt that there should not be a replacement appointed before the next town election.

The town is thinking of recodifying our general by-laws. We discussed the need for a committee to look at this to see how much needs changing. Are there by-laws that are unclear enough to lead to lawsuits?

We will start to put an article in every Bulletin about one aspect of town government. There is a need to encourage people to work on town boards. Could the applicants for town committees be described in the Town Crier so we know a little about them?

There will be a Moderator's Advisory Committee meeting to decide whether to accept a report that has been produced. Doug Gillespie has suggested appointing a new committee which will include a number of people who are currently on town boards, our LWV representative, and four open seats.

**O**n Monday, December 10, the Weston Council on Aging hosted a forum on emergency services in Weston with Police Chief Steve Shaw and Fire Chief David Sores as presenters. Not surprisingly, much of their attention was focused on our recent experience with Hurricane Sandy. The biggest problem with the storm was not the discomfort and inconvenience many homes in town experienced without electricity for three days. Rather, it was the danger inherent with so many fallen trees that made it impossible to drive on any road from Route 20 up to route 117. Police and fire trucks had to reach the north side of town by driving through Waltham, since Church Street, Conant Road and Concord Road were all impassible. The policy is that the Weston Public Works Department can only remove fallen trees that are not in contact with

any fallen wires. Those trees must be left to NSTAR to deal with. Weston found NSTAR to be frustratingly unresponsive to Weston's dilemma. The fire department actually sited a fire truck up on 117 to act as an outpost, in case of any medical or fire emergencies.

The town did set up a shelter at the High School for people who couldn't deal with cold, dark houses and no way to cook food, but found very few people who took advantage of that resource. Next time a shelter is needed, the chiefs think they will set it up at the COA, which they believe would be more appealing to Weston's elderly population. Below you can find a list of emergency supplies that every household should keep on hand. The list was distributed by COA nurse Theresa Levinson.

## **72 Hour Emergency Stay-at-Home Supply Kit**

### **Food & Water**

Water: 1 gallon/person; extra water for pet  
Food, three-day supply of non-perishable food and pet food  
Non-electric can opener

### **Fuel & Lighting**

Flashlight with extra batteries  
Candles (long burning)  
Matches  
Hand/body warmers

### **Equipment**

Radio with extra batteries or hand cranked  
Plastic sheeting and duct tape  
Whistle  
Cell phone, car charger, Blackboard Connect

### **Personal Sanitation & Medication**

First Aid kit  
Hand sanitizer  
Prescription medications, their original containers, and 3-day surplus supply

### **Personal Documents & Money**

Important family documents such as insurance policies, identification and bank account records  
Cash and change

### **Legal Documents**

Wills, passports, contracts, deeds, vehicle titles, and phone #s, stocks/bonds.

### **Medical Documents**

Medical & dental insurance numbers and phone #s  
Medical device serial numbers and manufacturer phone #s  
File of Life

### **Miscellaneous**

Emergency contact list both in state and out of state  
Specialty needs for elderly/infant/toddler  
Deck of cards/small games/ books

*\* Update your kit every 6 months to make sure that: all food, water and medication are fresh, documents are up-to-date and batteries are working.*



**WESTON TOWN MEETING ADVISORY COMMITTEE**

**A**fter sixteen meetings and eleven months, the committee held its last meeting on Dec.12, 2012, approved its report and voted to disband. The committee was requested by the moderator, Wendy Spector to consider four questions:

- Is there a better way to prepare citizens to vote on the issues?
- Is there a way to encourage people to go to the polls and attend town meeting?
- Are there protocols during TM that can balance the need to hear a range of opinions and to make timely progress on the issues at hand?
- Finally, can the office of the Moderator be modified to encourage candidates to run and to prepare new Moderators for their role?

The committee was self-selected and represented diverse backgrounds and opinions, which made for lively discussions. A final report was approved with all but one member signing on, and with two minority reports.

The Moderator attended many of the meetings and has already implemented a number of the recommendations from the committee. The final report will be available on the website.

One of the recommendations is for the Selectmen to appoint a committee to further study ways to improve Town Meeting. This has been done, although the members (from several town committees and with four at-large members) have not yet been appointed.

Most committee members believe that Town Meeting functions well, but there is substantial room for improvement.
