### The Dawn of a New Era

I am extraordinarily proud to be able to pen this special Opening Message for the January League of Women Voters of Weston bulletin. Katherine Wolfthal, our tireless and generous editor was willing to extend the deadline for me, so that I could cover the 2009 Presidential Inauguration, but I thought that some of our readers might have caught that without my reporting on it directly. However, Republican or Democrat; black or white, young or old, red or blue, I hope you will agree with me that this is an historic moment in our country's history. (Disclosure; I am cribbing from both 43 and 44, not in that order!)

It is particularly exciting that some of our League members are in Washington DC for this event, and many others are watching – with their parents, with their friends and with their children as our country, facing more serious and more numerous crises than at any time in the past two generations, watches yet another peaceful transition of power. I hope that in next month's League Bulletin, we will have some small excerpts from eye-witness experiences in Washington – on the mall, walking along the streets, watching the procession, seeing the inauguration live, celebrating right in the heart of the capital.

Clearly the country is caught up in this celebratory time – notwithstanding the dire economic straits in which we find ourselves – notwithstanding the two wars that we are currently waging – notwithstanding the continuing violence in the Middle East - and notwithstanding the gas heat crisis across much of Eastern Europe. I was listening to National Public Radio's coverage of the Birmingham, Alabama civil rights foot soldiers (the oldest of whom is 84) who are taking a bus late Monday from Birmingham to Washington. (They didn't want to miss the Martin Luther King, Jr. celebrations on Monday morning.) They don't have tickets, but they want to be on this small spot of land where a long awaited milestone will occur. The Tuskegee

The Board met at the home of Kathleen Rousseau.

There was a discussion of possible topics for future Saturday coffees.

The state has taken control of any new rail trails in our area. While there is enthusiasm to extend the trail through Weston, the state is very short of funds for such a project. The town may be asked to pay for the construction of the trail.

There was a long discussion of planning versus zoning issues when building in Weston. The planning board is thinking of requesting some changes to the regulations regarding the square-footage requirements for site plan approval.

We have a large number of members who have not renewed their memberships this year. If you are among them, we hope that you will remain a member of the League. You may hear from one of us in the near future. The state and national LWVs will be getting their per-member-payments soon, and they depend upon us for their activities.

Diana Chaplin has attended another planning meeting for the Civics Bee, to be held on March 1<sup>st</sup>.

Joe Mullin has offered to be a member of the adult team, and we are looking for the other two members of this team, plus alternates. U.S. history is taught in our schools in the 8<sup>th</sup> and 11<sup>th</sup> grades, so those are probably the classes from which the middle and high school teams will be drawn. There will be two coaching sessions before the contest.

The League Book Club (open to all) will meet on February 12 at Rochelle Nemrow's at 7:30 p.m.

We will be discussing *The Omnivore's Dilemma* by Michael Pollan.

There was not a lot of news about the CPC. The board is looking for new members. There were discussions on treating wooly adelgid; the Conservation Commission is trying a new treatment on some stands of hemlocks. The

court has ruled that CPC funds can be used for the maintenance of recreational lands only if the lands were bought with CPC funds. This may be changed by legislation.

### PEARLINGTON UPDATE

In November 2008 I joined nine women in Pearlington, Mississippi to work on the community center. All the women were skilled carpenters from Charlottesville, VA. A number of them owned their own construction companies.

We all were volunteers, working under the direction of the Building Goodness Foundation, the non-profit entity overseeing the construction of the community center. We painted walls and window trim, prepped and polyurethaned doors

and cut and installed window trim. Everyone was patient while instructing the one unskilled volunteer on the trip...

A final work crew from the BGF is in Pearlington this week, painting the outside of the community center, building the handicap ramp and completing the installation of the screens on the porch. Hancock County will oversee the final detail work on the building and the grounds. At the end of January the State of Mississippi will reclaim the MEMA trailers which are presently being used as housing by many MS residents who

have not yet completed construction of their houses. I do not know where these residents will live. I do not know why the State is demanding the return of the MEMA trailers. In November I passed acres of unoccupied FEMA trailers as I drove from Hattiesburg, MS to Pearlington. Perhaps the unoccupied MEMA trailers will keep the FEMA trailers company.

In late March Sally Currier and I shall fly to Mississippi and attend the dedication of the community center on March 21<sup>st</sup>.

### BOARD OF SELECTMEN - Jan. 6, 2009

#### 1. Cultural Council Candidate

Karen Gallagher was appointed for a three-year term.

#### 2. Housing Partnership Candidates

Ten volunteers interested in joining the Housing Partnership were interviewed. The number of committee members will be decided and committee members will be appointed by the Selectmen at their next meeting on Wed., Jan. 14, 2009. The Partnership Committee will undertake a comprehensive look at Weston's affordable housing stock and affordable housing needs. A copy of the charge is available at Town Hall.

#### 3. Telecommunications Facility – Cat Rock

Susan Haber, Town Planner presented a proposal from T-Mobile to put a 100 ft. monopole at Cat Rock to improve cell phone coverage within the town. The town would be compensated. There was discussion as to whether a freestanding monopole or something attached to the standpipe would be preferred. It was decided to issue an RFP for several different heights and locations.

### BOARD OF SELECTMEN – Jan 14, 2009

#### 1. Permanent Building Committee candidates

Two volunteers were interviewed and James Blundo was appointed to the PBC for a 3 year term. He has experience in building design and as a plumbing and fire system engineer.

#### 2. Permanent Building Committee – DPW Facility Questions.

Mark Susser, Chair asked for guidance on septic system location and size. A larger system to accommodate a future new Police Dept. would impact the current location of the salt storage area and would add about \$200K to the cost. The Selectmen indicated that it would be prudent to plan for the larger system. The PBC expects final bids by the end of April.

#### 3. Billboard on Rtes. 90 and 128

Pete McCleary, a Weston resident, alerted the Selectmen to the likelihood that large billboards could appear along these highways without any regulation by the Town. He suggested the town hire a consultant to advise how to prevent this. One suggestion was that the Town issue permits that don't require that anything be built for some of the most likely areas and then not do anything. These permits would be valid for 1 year. No decision was made.

#### 4. Housing Partnership Appointments

Steven Charlip, Susan Haber, Wendy Kaplan Armour, Ted Kirchner, Shirley Dolins, Sarah Rhatigan, Bill Donnelly, Hugh Jones, Keith Gross, Shams Alam, Rev. Steve Melius, Nicholas Timperio. William Kelsey, Thalia Price and Polly Dickson were appointed. There are representatives of elected officials, town employees, the current WAHFI committee, finance professional, local clergy, real estate developer (who does not do development in Weston) and residents with experience related to



housing, fund raising, development and/or management. A Chair will be designated at the first meeting.

#### **5. FY10 Preliminary Budget and Revenue Projection**

Donna VanderClock, Town Manager presented an overview. Her recommendation would not require an Override, and would provide a current level of service. The property tax levy, because of new construction, would be increased by 5.3%. A 10% decrease in State Aid is assumed and a 9% decrease in local receipts. Total revenues would then increase 2.7% to \$62,880,833. The property tax provides 86.2% of revenue.

Capital Requests would be contingent on approval of a debt exclusion vote at the election and would include DPW equipment, DPW new facility (\$12,000,000), technology (phone system and network), School bus replacement and Field school (\$600,000). Water main rehab and storage tank maintenance would be paid for out of water revenues as well as the water dept. share of the DPW building (20% of total cost).

\$330,000 from the free cash account will be used for the unfunded pension liability in addition to the assessment. \$100,000 will be put in the stabilization fund with a possibility for \$200,000 more and \$50,000 will be added to the snow and ice budget.

Projections for FY11 and FY 12 indicate a significant shortfall then.
